Rules & Policy's:

Rules:

- 1.) To be nominated; receive an award or perform during the CBMA Weekend: ***You, your band and/or your organization "must" be a member of the Carolina Beach Music Academy in good standing.***
- 2.) All CBMA Hall of Fame Members are "Automatic Members" of the CBMA Academy and do not have to join. You are an automatic member if the band you play in is in the HOF. If you leave that band and join another band that is not a HOF member, then you are no longer in the HOF unless you've been inducted into the CBMA HOF as an individual.
- 3.) You must be a member in good standing and have not violated any rules or policies of CBMA.
- 4.) All performing members must sign a non-compete contract not to play within 10 miles of the event during the week associated with CBMA without prior approval or authorization of CBMA. Also, each venue must sign an agreement contract with the same non-compete clause to be a part of CBMA Weekend.
- 4.) **No Band, Artist or Individual may make or post any derogatory remarks towards other CBMA Members and/or the Organization. This includes spouses and girlfriends of Artist.**
- 5.) Anyone violating any of the above rules will be subject to disciplinary policies listed below.

Policies:

- 1.) First violation of the above rules will result in 1 year suspension from competition of awards and participation in CBMA Weekend events. (All infracting entities)
- 2.) Second Violation will result in 3 years suspension from competition of awards and participation in CBMA Weekend events. (All infracting entities)
- 3.) Third Violation will result in suspension of a length of time to be determined by the Board of Directors up to and including permanent suspension. (All infracting entities)
- 4.) These policies will be enforced 100% starting in the year 2005 by CBMA.
- 5.) The Board of Directors have the right at any time to enforce suspension at any level they see fit for the severity of the infraction up to permanent removal and forfeiture of all present and past awards including removal of all reference to CBMA, Cammy, Cammy Awards, Beach Music Awards, Carolina Beach Music Hall of Fame, CBMA Hall of Fame, Cammy Hall of Fame etc..... From all locations and advertising associated with that entity. This can and will be legally enforced through copyright and service mark infringement.
